**Lutheran Church of the Cross-** July 20, July 27, August 4 via zoom meetings- Our church council is 100% in favor of our school reopening.

**Parent Stakeholders-** May 21, July 21, 22, 24, 29 via email and App – When surveyed, 86% of parents were in favor of on-site learning. At this point, 5.3% of our students will be participating in distance learning.

**AVCS Staff-** May 21, July 21, 22, 24, 29, August 4 via email and zoom meetings.

If no labor organization represents staff at the school, please describe the process for consultation with school staff:

AVCS Administration has consulted with school staff over the past four months via mandatory zoom meetings, emails, and statement of support completed through school App. Administration gathered input and feedback from staff on level of comfort returning to campus with students. One teacher has chosen to take a personal leave for the school year due to health concerns and traveling to care for her father who lives out of state. Administration has made accommodations for 1 high risk teacher who will be the teacher working with our remote learners. Another one of our staff members has been assigned the role of TOSA (Teacher on Special Assignment). This teacher will be an additional teacher on site each day to support our classroom teachers and be the resident substitute teacher for consistency. At this time all teacher positions are filled with teachers who feel comfortable returning to campus and are committed to following and supporting the COVID Action Plan.

## II. Elementary School Reopening Plans
